

Privacy Policy for ADM Doctor of Physical Therapy, LLC Updated on August 27, 2025

Introduction

A.D.M. Doctor of Physical Therapy, LLC ("we", "us", or "our"), operates the following website: Www.ConciergePTatHome.com (the "Service"). We are committed to protecting your privacy and personal information. This policy is designed to explain how we collect, use, store, and disclose information when you use our services and your choices with respect to data collection and utilization.

What Information We Collect

While using our service, we ask you to provide personally identifiable information (PII) that will be used to contact and identify you ("Personal Data"). PII may include but is not limited to:

- First and last name

- Tracking Cookies Data: We use cookies and similar tracking technologies (e.g. Beacons, tags, and scripts) to monitor and track activity on our Service and store certain information. Cookies are small data files with anonymous identifiers, sent to your browser and stored on your device. You can set your browser to refuse cookies or alert you when they're being sent. However, some parts of the service may not function properly without them.

How We Collect Your Information

Your information is collected in several ways:

- Directly, when you fill out forms, book appointments, e-mail us, or speak with us
- Automatically, via our website cookies or analytics tools

- Through third-party platforms that help us manage appointments or process payments

Sharing Your Information

These service providers are carefully selected and meet high data protection and security standards. We only share information with them and that is required for their services.

If A.D.M. Doctor of Physical Therapy, LLC Is involved in a merger, acquisition, or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different privacy policy.

Data Retention

We retain your Personal Data only as long as is necessary to provide services and comply with legal obligations, enforce our legal agreements, resolve disputes. We will also retain Usage Data for internal analysis purposes. Usage data is typically retained briefly, unless needed for security, service improvements, or to comply with legal requirements. When records are no longer required, we securely dispose of them.

Teletherapy, Telehealth, Virtual, Appointments; Appointments by Telephone

- Teletherapy appointments are not routinely recorded. If an appointment needs to be recorded for supervision, training or, or other legitimate reasons, your explicit written consent will be obtained in advance. You may decline recording at any time without affecting the access to your services.
- If session is recorded (with your express written consent), the Recording will be stored in the secure, encrypted digital format. Only authorized personnel will have access to recordings. The files will be retained only as long as necessary for stated purpose and then permanently deleted.
- clinical notes from teletherapy sessions are stored in a secure system that is HIPAA compliant. These notes contain only the information needed for your care and do not include appointment recordings.
- All electronic files, including potential recordings and appointment notes, are protected by strong passwords, encryption, and access restrictions. We follow the best practices to secure client information and comply with relevant privacy regulations, such as HIPAA.
- You, the client, have the right to know about, access, and request deletion of any recording in accordance with legal and ethical guidelines. No recording will be shared or used for purposes outside of those for which you have given consent.

Your Rights Over Your Data

You have rights to:

- Right to access, rectify, erase, restrict, withdraw consent, and/or update the Personal Data and processing, where permitted by law
- Right to access and receive a copy of your Personal Data
- Right to object or request data portability
- Right to receive an accounting of disclosures
